This is to give you notice that HomeServices of Washington, LLC doing business as Berkshire Hathaway HomeServices Northwest Real Estate (“Berkshire Hathaway HomeServices Northwest Real Estate”), HomeServices Relocation, LLC, Prosperity Home Mortgage, LLC, Equity Title of Washington, LLC and, HomeServices Insurance, Inc.
