- Planning to attend either a certified trade school or accredited post-secondary institution
- Possess a minimum GPA of 3.0
- Parent(s)/Legal Guardian(s) is Active Duty US Military Personnel

## SUBMISSION REQUIREMENTS

- ✓ Completed Towne Realty Foundation application packet (parts 1-5)
- ✓ Two letters of recommendation (can be from a Teacher, Coach, School Administrator, Clergy, Civic League Leader or Governmental official)
- ✓ Typed or hand-written essay
- ✓ Transcript/GPA Scale
- ✓ Towne Realty Foundation Scholarship Acknowledgement form signed by Student and Parent/Legal Guardian.
